

## **HBH Foundation Trust - Purpose**

- To encourage and provide for individuals and other entities to make charitable donations to an Endowment Fund.
- To invest and grow the Endowment Fund such that it generates income which can be used to provide financial and other assistance to Hamilton Boys' High School.

## **HBH Foundation Trust – Objectives**

- To assist Hamilton Boys' High School to further develop and strengthen its position as an educational leader by providing funds, aside from funds received from the Ministry of Education, to enhance the school's programmes and facilities in the academic, arts, cultural and sporting fields.
- To raise awareness amongst former students and staff together with the wider community of the HBH Foundation Trust's purpose.
- To grow and enable significant development of the school's database of former pupils and staff.



## Trustee's Modus Operandi

- Act in the interest of the HBH Foundation Trust
- Engage with Hamilton Boys' High School Old Boys and the wider community.
  - Explaining the purpose of the Foundation.
  - Seeking their direct financial contribution to the Foundation Trust Fund.
  - Seeking their personal contribution of specialist skills when appropriate.
  - Regularly update (twice yearly) the status of the Foundation and progress made since its inception.
- Administer the Foundation with integrity, meeting at least six times per year.
- Protect and preserve the endowment fund, distributing only earnings from the principal.
- Engage with the HBHS Headmaster and/or a nominated assistant as appropriate to solicit requests and/or ideas for and agree distributions from the Foundation Trust Fund.
- Engage with corporate entities, businesses and/or appropriate community focused entities seeking direct financial or inkind contribution to the Foundation Trust Fund.



 $Following \ are \ extracts \ from \ the \ Hamilton \ Boys' \ High \ Foundation \ Trusts \ Deed \ clarifying \ all \ Trustees \ duties \ and \ obligation \ \dots$ 

#### 3. Trust To Be For Charitable Purposes

- 3.1 The Trustees shall hold the Trust Fund to carry out within New Zealand any purpose recognised by law as charitable for the purposes of the Charitable Trusts Act 1957, Charities Act 2005 and the Income Tax Act 2007 (or Act in substitution) and for the public benefit whether in respect of relief of poverty, advancement of education, or for any other purpose or object charitable at law.
- 3.2 Without limiting clause 3.1, the Trust shall focus on the general educational purposes of Hamilton Boys' High School ("the School"), the School's students and the School's teachers.
- 3.3 Without limiting the above, the Trust's objectives are (in no particular order of importance):
  - to raise funds and establish an endowment fund from which the income can be used to assist the School and the School's students, prospective students and teachers;
  - to co-ordinate fundraising and raise funds for capital projects which benefit the School's students and teachers;
  - to provide specialist equipment, facilities, land, buildings, resources, and materials for use by both teachers and students of the School;
  - to provide assistance to teachers of the School to enable them to advance their education including the sponsoring of overseas educational courses and experiences; and
  - e. to maintain a database of the School community (past, present and future).

#### 10. Payments to Trustees

- 10.1 Except as stated in paragraph 10.2 every Trustee is prohibited from deriving any benefit or advantage or income from the Trust.
- 10.2 The Trustees may employ as agents, officers and staff, persons who are Trustees but:
  - No Trustee or person associated with a Trustee may participate in or materially influence any decision made by the Trustees in respect of income paid to or on behalf of that Trustee or person; and
  - b. Any income that is paid must not exceed ordinary commercial rates for the services supplied.

Hamilton Boys' High School must maintain the ability to provide opportunities for all boys, regardless of their personal circumstances, to obtain an education based on the pursuit of excellence. Offering ongoing excellence at Hamilton Boys' High School to the students of today and the future will only be achieved through a funding structure not available through traditional sources. As a Foundation our ambition to raise a substantial fund is central to this outcome and will be more so in the future. Superior facilities, exceptional teachers and mentors, committed to the very highest standards are essential to creating in each student, the desire, determination and confidence to reach their potential. The Hamilton Boys' High Foundation Trust is committed to developing a well managed and sustainable charitable fund that enables the School leadership team to ensure, through a broad range of initiatives, that each student leaves school well equipped to deliver on their promise. This will add to the school's proud history of past students achieving success both individually and within their community.

## Realising their Potential


Our school's history is a chronical of the success of its Old Boys and a testimony to the environment created within the school for so many years.

## Hamilton Boys' High Foundation Donation Policy

Provide an opportunity for people and organisations to support Hamilton Boys' High School through donations, sponsorships, bequests and other forms of gifting to an Endowment Fund.

Build and maintain a strong capital base which generates positive investment returns.

Our aim is to raise a capital fund of more than \$1 million within two years of the Foundation launch. From there, build to a capital fund of more than \$5 million within 10 years, which should provide an annual income stream of \$200,000.

The opportunities for donors to support the Foundation are as follows:

Gold Donor: \$20,000 or more.

Silver Donor: \$5000 or more but less than \$20,000. Bronze Donor: \$1000 or more but less than \$5000. Friends of the Foundation: payments of less than \$1000.

Contributions by way of bequest or pledge will qualify for these categories on receipt of donation.

#### **Founder Donor**

A Founder Donor will be a donor who makes a payment (as per the above qualifying levels) within the first 12 months of the launch date of the foundation. This can be a lump sum or a spread payment as long as the spread payments add up to the qualifying sum within the 12 months).

A Founder Donor will be recognised in the following way: will always have the word "Founder" after their name in the list of donors included in any published material.

Charitable Trust status. All charitable trust donations qualify for a tax credit claim from the Inland Revenue Department.
